# The Columbus Foundation offers donors maximum flexibility by offering a variety of investment options.

The following investment options are available. Fund advisors can choose one of these investment options per fund. Separate administrative fees apply.

### **INVESTMENT OPTIONS**

# 1 Invest your fund with Advisory Pools, offered through Mercer

Donors have the option to choose from five different advisory pools that we developed with targeted allocations ranging across the risk spectrum.

| <b>Advisory Pools</b> | Allocation                     |
|-----------------------|--------------------------------|
| Growth                | 80% equities, 20% fixed income |
| Balanced Growth       | 60% equities, 40% fixed income |
| Moderate Growth       | 40% equities, 60% fixed income |
| Conservative Growth   | 20% equities, 80% fixed income |
| Fixed Income          | 100% fixed income              |

The benefits of these advisory pools include constant oversight from our investment advisory team at Mercer, as well as disciplined rebalancing back to allocation targets on a quarterly basis, if necessary. Each pool is made up of a selection of Vanguard index mutual funds as well as actively managed mutual funds. Mercer charges an advisory fee of .045% for the investment management of the advisory pools.

# 2 Invest your fund with the Vanguard Family of Funds

Donors have the option of choosing from a menu of nine low-cost Vanguard mutual funds. These funds offer a history of competitive returns as compared to their benchmarks and have some of the lowest internal fund expenses in the industry.

# 3 Invest your fund with an approved investment partner

The Columbus Foundation works with more than 30 investment partners to manage fund assets. These firms have all been approved by The Columbus Foundation's Governing Committee, and the fund assets must reach \$100,000 or more to work with an approved investment partner.

Funds are invested with varying allocations. Portfolios are constructed in consultation with The Columbus Foundation, the fund advisor(s), and/or their specified investment partner based on risk tolerance and the fund's time horizon. The Columbus Foundation's preference is to have portfolio construction made up of low-cost mutual funds and/or exchange-traded funds. Specific investment in certain equities and/or fixed income holdings will be considered on a case-by-case basis.
